Librarian Musings: Tour of the Historic Fort Bend Courthouse

Recently, I had the opportunity to get a tour of the historic Fort Bend Courthouse. I have been in there before, for Commissioner's Court hearings, but I had not been in there to learn the history of the building. I had the opportunity during our annual Southwestern Association of Law Libraries' conference, which happened to be in Sugar Land. This year, I was part of the Local Arrangements committee and one of the items on the agenda I wanted our members to see was the historic courthouse.

Built in 1908, it is the fourth Fort Bend courthouse and is an example of classic revival architecture. It cost about \$75,000 to build and the land was purchased for \$6,750. It was added to the National Register of Historic Places in 1980. It has seen a couple renovations and expansions over the years including the most recent one in 2012. The Law Library used to be housed in that building on the 3rd floor and was there for 20 years. We now currently reside in the sixth Fort Bend Courthouse, the Justice

Center.

I was surprised to know that the historic building used to be bigger than it is now. Additions were added in the 1930s and 1950s that were removed in the 2012 renovation. The renovations at that time returned the building to what it looked like before the 1930s renovation as they were able to find the original paint color after removing many layers of paint. They found some of the doors from the third Fort Bend Courthouse, which they have added to building. The rotunda is astounding as it rises up from the first floor. Surprisingly enough, there are windows on the outside you cannot actually see form the rotunda floor but bring in extra light.




On the second floor, there is the renovated historic courtroom which has some original elements including the balcony and jury box. The judges bench is not original but has been remade to look like it would have at that time.

Today, the County Judge has his offices as well as the Commissioner's Courtroom is located there. The County Attorney's office is located there and many of the areas of the building are not available to the public. However, the Fort Bend Museum gave a wonderful tour.

If you have time, please go and see the historic courthouse especially if you have not seen it since before the renovation.

The Law Library has added a new title in *Handling Federal Discovery* from James Publishing. This title goes well with some of our other Federal resources. This one in particular focuses on the admission of evidence and the use of discovery. The new revision also adds a discussion of digital discovery including new technologies, remote depositions, and how these technologies change discovery practice. There is also ample discussion on how the COVID 19 pandemic has altered the landscape as well. The book is broken up into sections detailing discovery from beginning to end including planning, investigation, previlige, disclosures, interrogatories, requests for production, inspections, requests for admissions, and more. Each section details the primary law that governs this area as well as any forms you might need. The forms can be found both on our Lexis Advance database or Lexis Digital Library. If you get them from Lexis Advance, they will download in Word format. From Lexis Digital Library, they will be in PDF. Copies of the print book can be made for \$0.10 a page. The book is written by William M. Audet, Kimberly A. Fanady, and David Link Y. Kuang. All three authors have years of practice in federal court in

Technology Corner: Update on Hein Online

I think most of our patrons are familiar with our two primary online legal databases Westlaw and Lexis that provide an incredible depth and breadth of primary (cases and statutes) and secondary (practice guides, forms, etc.) resources. Hein Online, one of our other legal databases, gets overlooked. It is not directly comparable to Westlaw or Lexis but it provides a broad collection of legal resources that range from the practical to the more historical and academic. Starting with the practical, Hein offers a much deeper collection of law reviews and law journals than Westlaw or Lexis, especially in terms of the date range available....for example, an attorney patron recently asked for a 1965 article from the Washington & Lee Law Review....I started on Lexis but found it only went back 30 years or so, but Hein had it so I e-mailed it to myself, saved it on my thumbdrive in PDF and forwarded it to her. Other materials available on Hein are the U.S. Code and the Code of Federal Regulations. Some other great resources are: the Manual of Patent Examining Procedure, which is the go-to publication for patent attorneys and their dealings with the U.S. Patent & Trademark Office; the National Survey of State Laws, a compendium of comparative law across the 50 states on all manner of issues from abortion to drug laws minimum wage laws, and martial property – 60 areas of law in all; State Attorney General Reports and Opinions; Congressional, Presidential, and Supreme Court materials; foreign legal materials; U.S. Treaties; historical documents such as the "Pentagon Papers"; a vast collection of materials on slavery in the U.S.; and much more. Access to Hein Online is at no charge and is available on 8 of our 10 patron computers. Printing from Hein is 10 cents per page for black and white. The materials on Hein can be e-mailed to you or downloaded to a thumbdrive for free. Another interesting feature is that Hein Online can be accessed by all Justice Center visitors via laptop though the County's wi-fi: fbeguest. For more i

Criminal Law—Habeas Corpus—Actual Innocence vs. Involuntary Plea

Ex Parte Ray Anthony Hicks, 640 S.W.3d 232 (Tex.Crim.App., 2022). Defendant/Applicant pled guilty to forgery of a government instrument, to wit a \$100 bill, and was sentenced to 180 days in state jail. Defendant subsequently filed an application for writ of habeas corpus based on actual innocence as the \$100 bill thought to be a forgery was determined to be genuine by the U.S. Secret Service. Not so fast said the Court of Criminal Appeals....despite these facts he is not actually innocent based on factual impossibility because he possessed the requisite intent to commit the crime at the time his knowledge was that the currency was a forgery. However, the Court of Criminal Appeals found that his guilty plea under these circumstances was involuntary....he made the plea under a mistaken belief regarding the specific evidence to be used against him. Relief was thus granted and Defendant was allowed to withdraw his plea, judgment was set aside, and Defendant was remanded back to the trial court to answer the indictment.

Family Law—Divorce—MSAs—Fiduciary Duty

In the Matter of the Marriage of Leticia G. Moncur and Ross S. Moncur, 640 S.W.3d 309 (Tex.App.-Houston [14th Dist.] 2022, no pet. h.). This somewhat lengthy opinion in this divorce case is fairly fact-driven with the law as applied and is worth a read for any family law attorney dealing with marital estates and marital settlement agreements (MSA). Wife appeals on several issues, notably seeking to rescind the MSA because her husband had a fiduciary duty to her and failed to disclose material facts. As the 14th Court noted, her "task in this appeal is decidedly an uphill one. She contends that she reasonably relied on information that was obtained piecemeal, but she failed to engage in a complete discovery process before mediating and, indeed, agreed to waive further discovery in signing the MSA. It should go without saying that a contested divorce is an adversarial proceeding. Parties must act to protect their own interests. On this record, Leticia has not established either that the evidence conclusively established all elements of her fraud by non-disclosure claim or that the trial court's adverse finding on that claim was against the great weight and preponderance of the evidence." The Court pointed out that "While it is true that marriage creates a fiduciary relationship, the fiduciary nature of the relationship terminates when each spouse is independently represented by counsel in a contested divorce proceeding." On this issue ultimately the Court found that the wife "has not established that the trial court abused its discretion in refusing to set aside the MSA" thus overruling this issue. In the end the Court of Appeals affirmed the trial court's final decree that incorporated the MSA by overruling all the wife's issues on appeal.
