

### Featured Resource: Legal Information Buyer's Guide & Reference

Have you ever needed to know what books and resources are available in your area of practice? Look no further! The *Legal Information Buyer's Guide and Reference Manual*, by Kendall F. Svengalis, has the answers you need. This guide has become the go-to guide for Librarians, Practitioners, and Judges needing to find the right resource and practice guide for their collection. Winner of the Joseph L. Andrews Legal Literature Award, this book is the only one dealing with legal-information resources. The book is broken up into sections that include general views on legal resources, categories of legal publications, subjects and areas of law, and resources for each state. Additional appendices go into more detail about contact information for various legal publishers and used law-book dealers. Each title describes the author and includes a short description of the book and how it could be used, the cost, and each edition of the publication and frequency of updates. Unfortunately, 2021 is the last edition of this book and the Law Library recently purchased



it. Kendall F. Svengalis is a retired adjunct professor of Library and Information Studies at the University of Rhode Island. He was also the State Law Librarian for the state of Rhode Island, appointed by the Rhode Island Supreme Court. He has been producing this manual since 1996. ### Technology Corner: Secondary Resources on Westlaw and Lexis

The Law Library's two primary online legal databases are Westlaw and Lexis, available on computers 1 through 6. These legal databases provide up-to-date case law and statutes of all 50 states and the federal system. However, the Law Library's subscriptions to these databases provides so much more, including the ability to see the current history of the cases and statutes, via KeyCite and Shepard's, and forms from numerous resources. An area where these two databases really shine is their secondary resources. Secondary resources are essentially anything that is not primary law, i.e., cases and statutes. The main type of secondary resource the Law Library's databases offer are practice guides. These practice guides cover a wide variety of legal topics and provide the nuts and bolts for carrying on all manner of cases and the individual legal processes, pleadings, motions, hearings, discovery, and so much more that can occur in a case. For example, in defending a criminal case, you might want to quash the indictment. Lexis' Texas Criminal Practice Guide provides detailed information on the legal background underpinning such a procedure, applicable case law and statutes, practice tips on determining the validity of the indictment and drafting the motion to quash, and forms for doing so under various circumstances. Also, in the area of criminal defense practice, O'Connor's Texas Crimes & Consequences and Texas Criminal Offenses & Defenses (available via Westlaw) provide user-friendly and easy-to-follow compendiums of pertinent information on crimes, including their elements under the penal code, punishments, enhancements, lesser included offenses, defenses, and more. O'Connor's/Westlaw also produces numerous other practice guides in many areas of Texas law: Rules of Evidence Handbook; Probate Law Handbook, the venerable Civil Trials; and, the Family Law Handbook. Lexis' Texas-focused practice guides include Dorsaneo's Litigation Guide (you would be hard pressed to find a more complete publication); Family Law: Practice & Procedure; the previously-mentioned Criminal Practice Guide; Estate Planning; and, Probate, Estate, and Trust Administration. James Publishing's materials are available via Lexis including practice guides on DTPA and estate planning and probate. These are just some key examples of the myriad resources that help attorneys and pro se alike determine real-life applications, putting the law into use, and showing how things are done. There is no charge to access Westlaw and Lexis. Printing is 10 cents per page for black and white. These materials can be e-mailed to you or downloaded to a thumbdrive for free. #### Criminal Law—Expunction

Ex Parte J.C.F., Jr., 645 S.W.3d 783 (Tex.App.-San Antonio 2022, no pet. h.). Defendant who had been convicted of securing the execution of documents by deception had sought and been granted an expunction. Prior to this, he had been granted early discharge from community supervision. The Texas Department of Public Safety brought a restricted appeal challenging the granting of expunction. The San Antonio Court of Appeals determined that it had jurisdiction to hear the restricted appeal and then sustained the DPS' point of error, holding that the clear language of Texas Code of Criminal Procedure Article 55.01(a)(2) (a person is entitled to expunction if "there was no court-ordered community supervision") made the defendant/appellee ineligible for expunction. Reversed and rendered. A pretty black-and-white determination to be made in this case, but an important one to remember — a factor that can often get overlooked or misunderstood, especially by pro se litigants.
