

Featured Resource: Blue's Guide to Jury Selection

Do you need help conducting voir dire, getting jurors to talk, and keeping good jurors on the panel? *Blue's Guide to Jury Selection*, by Lisa Blue and Robert Hirschhorn, provides excellent advice on how to conduct jury selection. Lisa Blue and Robert Hirschhorn are well-known experts in jury selection and discuss these issues extensively. Lisa Blue was named "Top 50 Women Litigators in the U.S." by the *National Law Journal* and "Trial Lawyer of the Year" by the Texas Chapter of the American Board of Trial Advocates. Robert Hirschhorn is a nationally known jury and trial consultant. *Blue's Guide to Jury Selection* explains how to choose your best jury by reading prospective jurors' body language and controlling your own. Blue and Hirschhorn explain how important jury selection is because it is the only time you can have a conversation with your jurors who decide the verdict. Technology Corner: Westlaw and Lexis.....What's the Difference?!

Our two main online legal databases — Westlaw and Lexis — provide the full spectrum of Texas primary and secondary law along with up-to-date case law and statutes of all 50 states and the federal system and more. We use a lot of our budget to maintain a broad and deep collection of legal materials in print and online that our patrons need and expect. But what is the difference between them? Why both? I think it would be irresponsible to not have both of the key and recognized sources of legal materials. It would be like a restaurant offering coffee and not tea, or living in New York and not subscribing to the New York Times and the Wall Street Journal. To provide the broadest level of information, it requires both. Half of what the Times covers every day is also in the Journal...but the stories and the features that each uniquely provide makes them complementary while being valuable in their own right. We can easily describe the similarities...the text of the opinion of the U.S. Supreme Court case *Plessy v. Fer*guson is exactly the same from Westlaw or Lexis. The text of any statute is going to be exactly the same. The parts included with the *Plessy* opinion will have differences....with Lexis it is their case summary and the headnotes of key topics, whereas with Westlaw, it is the synopsis and West Headnotes. Or, if you were to do a search using particular terms, the results list may vary between the two based on how each's search engines process requests...a particular search on one might bring up a resulting list of cases, statutes, etc., with some variance from the other. I would expect there to be significant overlap, but there may be some key differences. Also, how things are presented may vary - such as with the results list of cases brought up by a particular search. I think Lexis provides a better description of the key aspects of each case. A crucial distinction is the secondary resources...both bring a lot to the table, and the ground they cover is the same. Some prefer the offerings of Lexis, whether it is the incomparable Dorsaneo's Texas Litigation Guide; Texas Family Law: Practice & Procedure; the Texas Criminal Practice Guide; Collier on Bankruptcy; etc. Others prefer the offerings of Westlaw, which most notably includes the entirety of the excellent O'Connor's 28-volume set of practice guides covering Texas and Federal civil and criminal law. Westlaw also has the Texas Practice Series; Corpus Juris Secundum; and many others. In assisting our patrons, I use both databases extensively every day. Working at an institution whose mission it is to provide the best possible breadth and depth of materials, I think it is essential to have both. Access to Westlaw and Lexis is free. Printing is 10 cents per page for black and white. The materials can be e-mailed to you or downloaded to a thumbdrive for free. Come by and see us and utilize the excellent offerings from Lexis and Westlaw!

Criminal Law—DWI

The State of Texas v. Jennifer A. Espinosa, 650 S.W.3d 849 (Tex.App.-Houston [14th Dist.] 2022, pet. granted). Defendant's/Appellee's motion to suppress all evidence seized and obtained during her DWI arrest was granted by the trial court. The State appealed. Defendant had been in a line of cars waiting to pick up children at an elementary school. Another citizen observed the Defendant in her parked but running vehicle apparently asleep and when she checked on her and smelled alcohol. Defendant asked the citizen to drive her home. A school employee intervened and said 911 had been called as to the Defendant. Defendant was no longer in her vehicle. A Houston police officer certified in DWI investigation came to the scene, interviewed witnesses including the citizen, the school employee, and a responding firefighter, as well as the Defendant. There were four empty wine bottles found in Defendant's car. None of the witnesses could testify as to seeing Defendant drive the vehicle nor did the officer observe this. The officer made observations of the Defendant that indicated alcohol consumption and her own statement was that she had come from home and was there at the school to pick up her child. She refused the field sobriety tests. She was arrested without warrant for suspicion of DWI. Her motion to suppress cited a lack of probable cause of DWI due to the lack of evidence of her actual operation of her vehicle while intoxicated. The trial court agreed. The First Court of Appeals disagreed with the State's contention that the officer had probable cause to believe that the Appellee had operated her vehicle legally intoxicated, stating: "The circumstantial evidence was insufficient to establish a temporal link between Appellee's intoxication and her driving. No one saw Appellee drive her car, and there was no evidence of Appellee's intoxication at the time she allegedly "operated" the car—as logically there could not be given that no witness could state when Appellee drove the car." The trial court's ruling was affirmed. A dissent was filed. Definitely worth a read for DWI counsel, et al.
