#### Trellis is Coming Soon! by Christine France

The Fort Bend County Law Library will soon have access to Trellis! Trellis is a legal database that provides access to state trial data, which includes dockets, judge rulings, and documents filed with the state trial courts. The database will allow you to view numerous county records across the United States, and simple searches will



enable you to determine how a judge, party, or opposing counsel has handled similar cases. You can also use Trellis to search by the title of the motion if you are needing an example to refer to. If you are looking to view filed documents, perform case searches, view case histories, or see judge analytics, come visit us at the Law Library!

# Featured Resource: Resources for Guardianship by Jonathan Briggs

Guardianship is the legal process whereby a "Guardian" is appointed by the Probate Courts (here in Fort Bend County, the County Courts at Law) to handle the affairs of an incapacitated adult (the "Ward"). It is a topic that we regularly deal with here at the Law Library, providing resources to attorneys and pro-se parties. Very typically, a parent or family member of a mentally-incapacitated person will come to us seeking the means to establish a guardianship for their loved one. It is usually either for an elderly person who is dealing with dementia, Alzheimer's, etc., or it is regarding a young adult with Autism or other incapacitating condition and the parents have lost the natural right to make the decisions for them. Since their child is no longer a minor and does not have the capacity to handle things for themselves -- such as decisions on healthcare, financial issues, etc. -- the parents have to go to the courts and seek a guardianship granting the authority and establishing the Guardian-Ward relationship so that they retain the power to act on behalf of their adult child.

To assist our patrons in pursuing a guardianship, we have many resources -- statutes, forms, and practice-guide materials.

The Texas Guardianship Manual from the State Bar is comprehensive, providing detailed information and extensive forms for this process. We have it in print, and it is also available electronically for downloading forms, etc., in the Law Library via a thumb drive we keep at the desk. Texas Probate, Estate and Trust Administration also provides excellent information about the process of seeking and managing a guardianship, as well as forms. It is available in print and online via Lexis **Plus** in the Law Library and via the **Lexis Digital** Library, accessible from the Databases page on Fort Bend County Libraries' website (www.fortbend.lib.tx.us). The O'Connor's series, available in print and via Westlaw in the Law Library, provides information and forms regarding Texas guardianship in the Probate Law Handbook, Estates Codes Plus, and Estate Planning Forms. Guardianship may not be the only answer to the situation a patron is dealing with, and the book Guardianship Alternatives can assist in exploring other options. We also have the entirety of the Estates Code available via Vernon's Texas Codes Annotated and all Texas case law on guardianship, both in print and online.


