## Featured Resource: O'Connor's Texas Crimes & Consequences

The 2018-2019 edition of O'Connor's Texas Crimes & Consequences has recently arrived. It is physically the smallest book by O'Connor's in the Law Library's collection, but it is one of the most information-packed volumes in the entire series of O'Connor's practice guides. It is an excellent resource for criminal defense attorneys, prosecutors, defendants, Judges, and court personnel. Crimes & Consequences provides a breadth and depth of crucial and readily accessible information on key areas of criminal justice practice laid out in a user-friendly form with numerous charts, including: Penal Code punishment ranges for all levels of offenses and other associated issues; punishment ranges for all manner of drug offenses; and information on such issues as culpable mental states, limitations, community service, sex offender registration, parole, sealing records, and lesser included offenses. This resource is indispensable in providing comprehensive information on the key topic of possible punishment ranges and issues affecting them. And true to its title, it also provides an accurate picture of the consequences of pleas or convictions to defendants facing charges. This and the entire O'Connor's series of practice guides are available for use by our patrons and are kept on their own easily accessible bookshelf across from the reference desk in our new library on the second floor of the Justice Center, open 8-5 M-F. Many of the charts from this publication are also available on the O'Connor's online database via its Criminal Law page on several of our patron computers. Copies and prints may be made for \$.10 per page.

## Texas Case Law Update

### Local Cases

### Criminal Law/ Constitutional Law

- *Billy Hawkins v. The State of Texas*, 551 S.W.3d 764 (Tex.App.-Fort Worth 2018, Pet. Ref'd.): Defendant was convicted of possession of less than a gram of methamphetamine and was sentenced to 6 months in state jail. In addition to the sentence of confinement defendant was also assessed \$349 in court costs, including a consolidated fee of \$133. On appeal Defendant argued that the fees pursuant to Local Government Code § 133.102(a)(1)(e.) violate the Separation of Powers Clause of the Texas Constitution, Art. II, § 1. Defendant took issue with the allocation of these fees to accounts and funds for “abused children’s counseling”, “law enforcement officers standards and education”, and “comprehensive rehabilitation” contending that it is unlawful taxation as the funds allow spending on things other than “legitimate criminal justice purposes.” He argued that the fees violated the Separation of Powers Clause by making the courts a tax collector, which is the function of the executive branch, not the judicial branch. Applying *Salinas v. State*, a recent Court of Criminal Appeals opinion, the Court of Appeals partly sustained Defendant’s point of error because the allocation of the fee to abused children’s counseling and comprehensive rehabilitation do not serve “a legitimate criminal justice purpose.” However, the Court of Appeals citing *Salinas* refused to apply its holding retroactively. Further, it upheld the fee in its funding of “law enforcement standards and education” as a legitimate criminal justice purpose. Thus the trial court’s judgment was affirmed. Defendant won a battle, but lost the war.
- *Alma Anderson v. The State of Texas*, 552 S.W.3d 321 (Tex.App.-Corpus Christi 2018, Pet. for Disc. Rev. filed July 2, 2018): Defendant was convicted of possession of less than 28 grams of Clonazepam (a medication that is often abused), a Class A Misdemeanor, and sentenced to 30 days of service in a work-release program. She appealed claiming that the trial court erred in admitting hearsay evidence, to wit, the arresting officer’s testimony that he utilized outside sources to identify the pills in question (the “Drugs.com” website and a book entitled “Drug Identification Bible 2014 to 2015”). The pills were found while doing an inventory of her vehicle following her arrest for DWI/alcohol. No actual testing of the pills was done. The Court of Appeals agreed that the evidence was hearsay and that the state failed to show that the arresting officer was an expert on drug identification, thus he could not sponsor excerpts from a learned treatise, an exception to the hearsay rule. This was found to be harmful error, thus the judgment of the trial court was reversed and remanded.

### Litigation/Health

- *Texas Health Resources v. Coming Attractions Bridal and Formal, Inc.*, 552 S.W.3d 335 (Tex.App.-Dallas 2018, Pet. for Disc. Rev. filed June 27, 2018): a nurse at Presbyterian Hospital in Dallas (owned/operated by Texas Health Resources “THR”) was among those exposed to a patient who died of the Ebola virus. The hospital assured the nurse and others that they were not at risk of contracting the virus and were free to intermingle with family, friends, and the public. The nurse subsequently visited the Coming Attractions bridal shop to select a dress for her upcoming wedding. She later came down with the Ebola virus. Health authorities ordered the bridal shop to be closed for cleaning due to her past presence there. The attendant publicity and stigma caused the store to lose customers and go out of business. The bridal store sued THR for negligence. THR brought a motion to dismiss based on plaintiff’s failure to produce the required expert report pursuant to Chapter 74 of the Civil Practice & Remedies Code when bringing a health care liability claim alleging the provider’s departure from accepted standards of safety as causative of claimant’s injury. Trial court sided with plaintiff but the Court of Appeals vacated the trial court’s order denying the motion, dismissed plaintiff’s case with prejudice, and remanded for a determination on THR’s attorney’s fees.
